Art in the Garden is operated by the Escondido Downtown Business Association for the express purpose of enhancing and promoting the Arts in Escondido. The goals of Art in the Garden are: • to attract visitors to the Historic Downtown Escondido and the Grand Avenue Festival. • To increase awareness of the Downtown as a unique retail, dining and arts district. • To promote Downtown Businesses and our rich cultural environment.

With large crowds and a wide variety of food and family entertainment, the festival is expected to provide all our vendors with a successful and enjoyable day, as it has since 1988.

The number of Artists showing a particular item/product may be limited at the discretion of the Art in the Garden Committee. However, there may be artists selling similar (not identical) artwork.

Location: Heritage Garden, Downtown Escondido at the corner of Grand and Juniper

Date: October 16, 2021 Art Fair Hours: 9:00 am – 4:30 pm

Returned Checks: \$35.00 fee for returned checks.

Set up/Clean up: Setup begins at 7:00 am and must be completed by 8:45 am. Vendors must not pack up and leave their space prior to 4:30 p.m. Please dispose of any trash before you leave. Please take packing, boxes, etc. with you!

Late arrivals: You must arrive for set up no later than 8am or may be considered a “no-show” and your space may be given to another artist. No refund for no show.

Cancellations: Must cancel ten business days prior to the date of Art in the Garden to receive a refund.

Weather: Art in the Garden is a “Rain or Shine” event. It is the sole responsibility of the Artist to be aware of weather conditions and take necessary and appropriate precautions. Artists are responsible for providing protective covers, weights, tie-downs, etc.

Parking: All vehicles must be moved off the Art in the Garden and Festival area no later than 8:30 a.m. Free parking is available.

Space Assignments will be sent via email one week prior to the event.

Display Spaces: Approximately 10’ x 10’, may be on dirt, grass, asphalt or concrete, be prepared for unlevel conditions. • Art in the Garden requires all Artists use quality displays that effectively showcase their art. This policy will be strictly enforced. Displays may not extend beyond the boundaries of the designated space. Chairs and other personal effects must remain within your space. • Artists provide their own equipment: structures, umbrellas, tables, table cloths, chairs, easels, and other support required to display their art.

Communications: All notifications are sent out by email. Payment reminders, space assignments and general information are sent via email. Coordination of Art in the Garden is all volunteer and does not include regular office hours; email and phone messages are checked daily.

Application Process: Applications are accepted and reviewed until the show is full. Acceptances will be sent weekly. You will be notified via email of acceptance.

Art in the Garden reserves the right to request removal of displayed work that does not reflect that which was submitted. Absolutely no imported, manufactured or mass-produced items, kits or articles not made in total by the artist. Exhibit must be staffed by the participating artist or artists at all times during Art in the Garden and Grand Avenue Street Fair. Artists are solely responsible for collecting monies for work sold and for payment of taxes to any city, county, state or federal agency. Artists are solely responsible for copyrighting their own work. Artists are prohibited from distributing literature or promoting in any other manner, any religious, fraternal, foundation, political or commercial organization.

Marketing: Art in the Garden is held in conjunction with the Grand Avenue Street Festival and will be promoted by MAGEC, the Escondido Chamber of Commerce and the Escondido Downtown Business Association. Artists are strongly encouraged share their participation in the show through social media and email.
